- 2. The Company had also placed the Notice of Postal Ballot on its web site as well as on the web site of Evoting Agency and web site of National Stock Exchange of India Limited and BSE Limited.
- 3. The Company has published the newspaper advertisement for date and time of commencement and end of remote e-voting and Postal Ballot in;
 - 1. Financial express (English Language) on May 23, 2023 &
 - 2. Financial express (Vernacular Language Gujarati) on May 23, 2023.
- 3. The Shareholders holding Shares as on the "Cut off" date, i.e. Friday, May 12, 2023 were entitled to vote through remote e-voting platform on the businesses mentioned in the Notice of Postal Ballot of the Company.
